#### **Proficiency Scale: Kindergarten to Grade 9**

Emerging	The student demonstrates an <b>initial</b> understanding of the concepts and competencies relevant to the expected learning.
Developing	The student demonstrates a <b>partial</b> understanding of the concepts and competencies relevant to the expected learning.
Proficient	The student demonstrates a <b>complete</b> understanding of the concepts and competencies relevant to the expected learning.
Extending	The student demonstrates a <b>sophisticated</b> understanding of the concepts and competencies relevant to the expected learning.
IE	(Insufficient Evidence of Learning) The student has not provided sufficient evidence of learning in relation to the learning outcomes for the course.

#### Letter Grades: Grade 10 to 12

A = 86 – 100	The student demonstrates <b>excellent</b> or outstanding performance in relation to learning outcomes for the course.
B = 73 – 85	The student demonstrates <b>very good</b> performance in relation to learning outcomes for the course.
C+ = 67 - 72	The student demonstrates <b>good</b> performance in relatiom to learning outcomes for the course.
C = 60 - 66	The student demonstrates <b>satisfactory</b> performance in relation to the learning outcomes for the course.
C- = 50 - 59	The student demonstrates <b>minimally acceptable</b> performance in relation to the learning outcomes for the course.
IE	(Insufficient Evidence of Learning) The student has not provided sufficient evidence of learning in relation to the learning outcomes for the course.
F = 0 - 49	(Failed) The student has not demonstrated the minimally acceptable performance in relation to the learning outcomes for the course. The letter grade F may only be assigned if an "IE" (Insufficient Evidence of Learning) letter grade has previously been assigned for that course.

## **English Language Learners: Levels**

These English Language Learning (ELL) descriptors are for students who meet the requirements for supplemental ELL supports and services.

Beginning	The student is beginning to understand basic English words and phrases.
Developing	The student is able to understand varying amounts of everyday English.
Expanding	The student is able to understand varying amounts of conversational English and academic language. Student is able to use a range of vocabulary to express ideas.
Consolidating	The student has an increasing understanding of the curricular content and competencies in Engligh. Student is able to use a range of academic vocabulary to express ideas.
Bridging	The student is approaching grade-level proficiency in English and is increasing independence to engage with cirricular competencies.
